The notice of meeting hall contain info mation on the form, time, en e, d ation and agenda of the meeting, time of i ance of the notice, name and contact info mation of the contact pe on of the meeting and other ele ant info mation.
- A ticle 20 Upon eccipt of the notice, all Committee membe hall p ompt1 p o ide confi mation and ele ant eplie (incl ding b t not limited to the confi mation of attendance, ched le and othe matte ) ia a p ope mean .

A ticle 21 The o m of a Committee meeting hall be the p e ence of all membe  $\ .$ 

A ticle 22 All membe of the Committee hall attend the meeting in pe on. If a membe i nable to attend the meeting in pe on, ch membe hall, b igning and bmitting a lette of po , a tho i e anothe membe of the Committee to attend and e p e opinion at the meeting on hi /he behalf. S ch lette of po hall e p e 1 tate the cope and te m of the a tho i ation. Each membe ma appoint onl one othe membe a hi /he po to e e ci e the oting ight on hi /he behalf. Whe e a membe a tho i e t o o mo e othe membe to e e ci e the oting ight on hi /he behalf, ch a tho i ation hall be in alid. In addition, no membe hall accept an ch a tho i ation f om t o o mo e othe membe conc entl .

The membe attending a meeting on behalf of anothe membe hall e e ci e the ight ithin the cope of a tho i ation. If a membe doe not attend a meeting in pe on o a tho i e anothe membe to e e ci e the ight on hi /he behalf, no doe he/ he bmit an opinion in iting p io to the meeting, he/ he hall be deemed to ha e ai ed hi /he ight.

- A membe ho i nable to attend a meeting in pe on ma al o e e ci e hi /he ight b bmitting in iting hi /he opinion ith e pect to an matte to be di c ed, p o ided that ch itten opinion hall be bmitted to the e ec ti e bod of the Committee befo e the meeting at the late t.
- A ticle 23 If a membe doe not attend a meeting in pe on o a thoi e anothe membe to attend ch meeting on hi /he behalf, no doe he/ he bmit an opinion in iting p io to the meeting on t o con ec ti e occa ion, o if ch membe fail to attend in pe on th ee- a te of all meeting of the Committee held d ing an ea, ch membe hall be deemed incapable of pe fo ming the d tie of the Committee, and the boa d of di ecto ma eplace him/he in acco dance ith the e Te m.
- A ticle 24 Meeting of the Committee hall be p e ided o e b the chai man of the Committee, ho ma appoint anothe membe to act on hi /he behalf hen he/ he i nable to attend the meeting. If the chai man of the Committee neithe pe form hi /he d tie no de ignate anothe membe to act on hi /he behalf, an membe ma epo t abo e it ation to the boad of di ecto , and the boad of di ecto hall de ignate anothe membe ho i an independent non-e ec ti e di ecto to f lifil the d tie of the chai man.

- A ticle 28 The Committee ma in ite di ecto, enio management membe and ele ant e pet of the Compan, e te nal e pet, chola, inte media agencie and othe ele ant pe on to it in on a meeting. S ch pe on being in ited hall gi e e planation and elabo ation on an i e a e i ed b an Committee membe.
